

# 百胜中国启动香港第二上市

2020年8月31日,香港 – 百胜中国控股有限公司("公司"或"百胜中国")(纽交所股票代号:YUMC),按2019年系统销售额计为中国最大的餐饮企业,今天宣布启动作为全球发售一部分的香港公开发售。全球发售将新发行41,910,700普通股股份(视乎超额配股权行使与否而定),公司普通股股份将于香港聯合交易所有限公司("联交所")主板上市,股份代号为9987。

公司股份将继续于纽约证券交易所("纽交所")上市交易。在香港完成第二上市后,公司香港上市的股份与在纽交所上市的股票将完全可转换。

本次全球发售包括初步提呈1,676,500股的香港公开发售新发行股份及初步提呈40,234,200股的国际发售新发行股份,分别占全球发售股份约4%及96%,在各种情况下均可按"全球发售的架构"所述基准重新分配,亦按超额配股权是否获行使而定。

香港公开发售的发售价("公开发售价")将于2020年9月4日或之前参考(其中包括)股票在纽交所的最后一个交易日的收市价厘定。公开发售价将不超过每股香港发售股份468.00港元。全球发售中国际发售部分的发售价可能将厘定为高于最高公开发售价的水平,视乎股份在纽交所最后一个交易日2020年9月4日或之前的收市价,以及根据专业及机构投资者在累计簿记建档过程中表达的申请意愿水平。股份将以每手50股股份为单位进行交易。

公司计划将发售所得款项净额用于i) 扩张及深化餐厅网络;ii) 投资于数字化及供应链、食品创新及价值定位提升、优质资产;以及iii)运营资金及一般公司用途。

香港公开发售将于香港时间2020年9月1日(星期二)上午九时正起开始,并于香港时间2020年9月4日(星期五)中午十二时正截止。预期公司股份将于2020年9月10日(星期四)开始于联交所交易。

高盛(亚洲)有限责任公司为本次发售的保荐人、联席全球协调人、联席账簿管理人及联席牵头经办人。花旗环球金融亚洲有限公司、招银国际融资有限公司、及UBS AG香港分行为联席全球协调人、联席账簿管理人、联席牵头经办人。
