2020年9月10日,香港 - 百勝中國拉股有限公司(「百勝中國」或「公司」)(紐交所股票代號:YUMC及聯交所股票代號:9987),按2019年系統銷售額計為中國最大的餐飲企業,今天於香港聯合交易所有限公司(「聯交 所l) 主板正式掛牌,成功在香港上市。

公司股份將繼續於紐約證券交易所(「紐交所」)上市交易,公司於香港上市的股份與於紐交所上市的股份將完全可轉換。
