



## 百勝中國於香港聯交所主板上市

2020年9月10日，香港 – 百勝中國控股有限公司（「百勝中國」或「公司」）（紐交所股票代號：YUMC及聯交所股票代號：9987），按2019年系統銷售額計為中國最大的餐飲企業，今天於香港聯合交易所有限公司（「聯交所」）主板正式掛牌，成功在香港上市。

公司股份將繼續於紐約證券交易所（「紐交所」）上市交易，公司於香港上市之股份與於紐交所上市之股份將完全可轉換。

百勝中國首席執行官屈翠容（Joey Wat）表示：「我感到非常自豪，能與四十多萬百勝中國的夥伴共同見證這個歷史性的時刻。我想藉此機會感謝全體員工的不懈努力。三十多年來，我們成功立足中國，已經發展成為中國領先的餐飲企業，此乃源於一代又一代百勝人的傑出貢獻。」

百勝中國一直秉承「餐廳經理第一」的文化，他們是公司最重要的領導崗位，公司獲得長期成功，有賴於他們的貢獻。在2016年獨立上市後，公司宣布授予每位符合條件的餐廳經理價值2,000美元的限制性股票，使超過9,700名餐廳經理成為公司的股東。在香港第二上市後，百勝中國也將向符合條件的餐廳經理授予價值3,000美元的限制性股票，預計本次計劃的第一年將授予超過4,000名餐廳經理，而首批限制性股票將在2021年2月頒發。

百勝中國在中國的餐廳網絡遍佈1,400多座城鎮，為中國成千上萬的民眾創造就業機會。百勝中國立志成為全球最創新的餐飲先鋒，致力於通過不斷升級餐廳消費體驗、持續推出創新產品，為消費者創造價值，同時滿足消費者不斷變化的需求。百勝中國將攜手行業夥伴，秉承價值創新，提升國內餐飲產業供應鏈現代化水準。同時，作為行業領導者，公司致力發揮所長，為社會帶來積極影響，回饋社區。
